Subject:

Revision of GST Rates on Jan Aushadhi Medicines.

In continuation of the recent notification issued by the Government of India regarding the revision of Goods and Services Tax (GST) rates applicable on medicines and medical devices, all Pradhan Mantri Bhartiya Janaushadhi Kendras (PMBJKs) are hereby instructed to note and implement the following changes with immediate effect:

#### 1. Revision in GST Rates:

The GST rates on certain categories of medicines and medical devices have been revised as per the latest Government notification. The updated GST ratio must be adhered to while procuring and selling the products through PMBJKs.

#### 2. System Updation:

- a. The revised GST rates will be updated in the PMBI portal.
- b. All PMBJKs must ensure that their billing systems reflect the revised rates to avoid discrepancies in invoicing and taxation.

#### 3. Stock Reconciliation:

- a. PMBJKs are advised to reconcile existing stock at the earlier GST rates before implementation of the revised rates.
- b. Proper records must be maintained for auditing and compliance purposes.

#### 4. Awareness and Compliance:

- a. PMBJKs must inform patients/customers clearly about the revised GST rates to maintain transparency.
- b. Ensure display of updated price lists where applicable.

#### 5. Strict Compliance:

The revised GST rates must be strictly applied from the effective date without any delay.

#### 6. Effective Date:

The revised GST rates shall be applicable from 22/09/2025.

All PMBJKs are directed to ensure timely communication to patients and strict adherence to the revised rates to maintain transparency, uniformity and compliance with statutory requirements.
